

## DECLARATION

**We**, the signing cities, refer to our cities as places of human rights and are convinced that a thriving and resilient democracy relies existentially on the participation of all residents in our cities.

We, as cities, recognize migration not as a state of emergency, but as a regular occurrence over the course of human history. Cities in particular are destinations for immigration and as the first and most direct democratic unit, they are responsible for securing the democratic participation of immigrants.

A democratic community needs work - from immigrants as well as from the host society. As cities we have to provide conditions in which immigrants see themselves as "equals among equals" or, where not yet given, will create them.

We welcome immigrants acquiring the nationality of our country but do not want residents to be excluded from equal democratic participation in our community because of the passport they hold. We do not look at our residents as people with different passports but regard all residents as citizens of our cities.

We, as signing cities, want more democracy in our cities and advocate the political participation of all our citizens - regardless of their passport. Citizens with EU passports have been active as voters and elected councilors for more than 25 years. The right to vote for the entire city population strengthens social cohesion, city identity and our democracy. Participation on equal terms is the democratic response to right-wing nationalism and discrimination.

With this declaration, we plead for the creation of the legal basis in our countries that equips all residents in our cities with the same democratic participation rights and makes them "equals among equals". In 14 out of 27 EU countries this is already common practice.

We will actively work to ensure that the right to vote and to stand as candidate will be guaranteed to our citizens regardless of their nationality on the local level - or in the case of cities which form a regional entity like Brussels, Berlin or Vienna, on the regional level.

To fulfill our goal, we as cities will take effective steps on our own initiative via our structures and political connections and will cooperate with local and supraregional organizations which work for equal political participation in our spirit.

Until local voting rights for all have been introduced, we will establish a review process to evaluate the progress and will report every three years in the city parliament on activities and achievements.

## DECLARATION

**Wir**, die unterzeichnenden Städte verstehen uns als Orte der Menschenrechte und sind überzeugt, dass für eine lebendige und resiliente Demokratie die Beteiligung aller Menschen in unseren Stadtgesellschaften existenziell ist.

Wir, als Städte, verstehen Migration nicht als Ausnahmezustand, sondern als Normalfall der Menschheitsgeschichte. Insbesondere Städte sind Zielorte der Zuwanderung und als erste, direkteste demokratische Einheit gefragt und herausgefordert, die demokratische Teilhabe der Zugewanderten sicherzustellen.

Das demokratische Zusammenleben ist eine Aufgabe für Zugewanderte wie für die aufnehmende Gesellschaft. Als Städte sehen wir uns in der Verantwortung, Bedingungen herzustellen, die Zugewanderte als „Gleiche unter Gleichen“ versteht oder - wo noch nicht gegeben - sie dazu macht.

Wir begrüßen, wenn Bürger\*innen die Staatsangehörigkeit unseres Landes annehmen, aber wollen nicht, dass Bürger\*innen aufgrund ihrer Passzugehörigkeit von der gleichberechtigten demokratischen Beteiligung in unserer Kommune/ Gemeinwesen ausgeschlossen sind. In unserem Handeln schauen wir auf die Bürger\*innen unserer Städte nicht nach ihrer Passzugehörigkeit, sondern verstehen alle Einwohner\*innen als Bürger\*innen.

Wir als unterzeichnende Städte wollen mehr Demokratie in unseren Städten und befürworten die politische Beteiligung aller unserer Bürger\*innen - unabhängig vom Pass. Seit mehr als 25 Jahren sind Bürger\*innen mit EU-Pass als Wähler\*innen und Stadträte\*innen aktiv. Das kommunale Wahlrecht für die gesamte Stadtbevölkerung stärkt gesellschaftlichen Zusammenhalt, Zugehörigkeit und unsere Demokratie. Partizipation auf Augenhöhe ist die demokratische Antwort auf Rechtsnationalismus und Ausgrenzung.

Wir plädieren mit dieser Erklärung für die Schaffung der gesetzlichen Grundlagen in unseren Ländern, die alle Bürger\*innen in unseren Städten mit den gleichen demokratischen Beteiligungsrechten ausstattet und sie zu „Gleichen unter Gleichen“ macht. In 14 von 27 EU-Staaten ist dies bereits unaufgeregte Praxis.

Wir werden uns dafür einsetzen, dass unsere Bürger\*innen unabhängig von der Staatsangehörigkeit das Wahlrecht auf kommunaler Ebene bzw. in Städten, die wie Berlin, Paris oder Wien eine Landeseinheit bilden, das Wahlrecht auf Landesebene - aktiv und passiv - erhalten.

Um unser Ziel zu erreichen, werden wir als Städte über unsere Gremien und politischen Möglichkeiten eigeninitiativ werden und mit kommunalen wie überregionalen Organisationen zusammenarbeiten, die sich für eine gleichberechtigte politische Partizipation in unserem Sinne einsetzen.

Bis zur Einführung des angestrebten Wahlrechts werden wir einen Evaluierungsprozess einrichten und alle drei Jahre in unserem Städteparlament über unsere Aktivitäten und Fortschritte Bericht erstatten.

## DICHIARAZIONE

**Noi**, Comuni firmatari, consideriamo le nostre città luoghi di rispetto per i diritti umani e siamo convinti che la partecipazione attiva di tutti i residenti sia essenziale per una democrazia prospera e resiliente.

Noi, come Comuni, consideriamo la migrazione non come uno stato d'emergenza, bensì come evento normale del corso della storia umana. Le città, in particolare, sono luoghi di destinazione dell'immigrazione e, in quanto tali, sono la prima unità democratica direttamente responsabile e chiamata a garantire la partecipazione degli immigrati

La convivenza democratica è un compito sia per gli immigrati che per la società ospitante. Come Città consideriamo nostra responsabilità creare condizioni che permettano agli immigrati di essere considerati "uguali tra uguali" o - dove questo non è ancora il caso - di renderli tali.

Accogliamo con favore la scelta di prendere la cittadinanza del nostro Paese e non vogliamo che nessuna persona sia esclusa dalla partecipazione democratica nel nostro Comune/comunità per via del passaporto in suo possesso. Nelle nostre azioni non valutiamo l'essere cittadina o cittadino delle nostre città in base al passaporto, consideriamo piuttosto tutte le persone residenti quali cittadine.

Noi, in quanto Comuni firmatari, vogliamo più democrazia nelle nostre città e sosteniamo la partecipazione politica di tutte le nostre cittadine e cittadini - indipendentemente dal passaporto. Per più di 25 anni, le cittadine e i cittadini con passaporto UE sono stati attive/i come elettorato e come persone eleggibili nei Consigli comunali. Il diritto di voto alle elezioni locali per tutta la popolazione residente rafforza la coesione sociale, il senso di appartenenza e la nostra democrazia. La partecipazione è la risposta democratica al nazionalismo di destra e all'esclusione.

Con questa dichiarazione, chiediamo la creazione di una base legale nei nostri paesi che fornisca a tutte le cittadine e a tutti i cittadini delle nostre città gli stessi diritti di partecipazione democratica e li renda "uguali tra uguali". In 14 dei 27 stati dell'UE, questa è già normalità.

Ci impegheremo affinché le nostre cittadine e i nostri cittadini, indipendentemente dalla nazionalità, abbiano il diritto di voto e di eleggibilità a livello comunale e nelle città che formano un'unità regionale come Berlino, Parigi o Vienna perché abbiano il diritto di voto a livello regionale.

Per raggiungere il nostro obiettivo, noi come Comuni intraprenderemo l'iniziativa attraverso i nostri organi politici e nell'ambito delle nostre possibilità politiche (e coopereremo) cooperando con le organizzazioni territoriali - municipali e sovrafforzate - che si adoperano per un'equa partecipazione politica.

Fino all'introduzione di una legge elettorale equa per tutti i residenti istituiremo un processo di monitoraggio e valutazione del processo e riferiremo sulle nostre attività e sui nostri progressi ogni tre anni in Consiglio Comunale.
